This report shows performance for the most recent month- and quarter-end for the investment options (Subaccounts) in the Thrivent Variable Annuity Account C (no longer available for purchase). Performance data for one year or greater are annualized; periods less than one year are not annualized. **The past performance shown is based on the change in unit values of the Portfolios and the effects of compounding. Since unit values are the same for all contract owners, the performance returns shown are based solely on the increase or decrease in the value of these units.**

All data represents past performance. Past performance does not guarantee future results. The investment return and principal value of the investment will fluctuate so that an investor's shares, when redeemed, may be worth more or less than the original cost. Current performance may be lower or higher than the performance data quoted. Visit Thrivent.com for performance results current to the most recent month-end.

Annualized total returns are based on the change in unit values at the subaccount level for the time period mentioned. **"If Surrendered"** values reflect the surrender charges that would have been applied had the contract been surrendered during any of the first six years. These charges are 6% in the first contract year, and decrease by 1% each subsequent year until they are zero. **"If Held"** values do not include surrender charges. All values reflect the deduction of the current mortality and expense risk charge of 1.10% and annual net operating expenses of 0.24% to 1.25%, depending on the Portfolio. Annual operating expenses are subject to change. Total returns are calculated from the date the subaccount was made available through the separate account used with this contract.

These returns do not include the annual administrative charge of \$30 deducted from any contract for which the total premiums paid under such contract, minus all prior surrenders, is less than \$5,000 and account value is also less than \$5,000. Inclusion of the administrative charge would reduce the total return figures shown. Periods less than one year are not annualized. Subaccount total return calculations assume an initial investment of \$10,000. At various times, the adviser reimbursed certain Portfolio expenses. Had the adviser not done so, the total returns would have been lower. See the Thrivent Series Fund, Inc. prospectus for more information.
